Ziningi izimo okukhulunye ngazo emthethweni, okumele ucele kuzo imvume noma uveze obala ngokuthi ubhale phansi ebhukwini lokubhala elibekiwe. Abasebenzi bakwa-Gold Fields abavumelekile ukuba nezikhundla ngaphandle kwaseNkampanini noma benze eminye imisebenzi ezobakhokhela imali – **ngaphandle uma kugunyazwe abantu abafanele futhi kuhambisana nemithetho Yendlela Yokuziphatha.** Imvume ebhaliwe kumele ifakwe kuRejista yokubhalisa Ukushayisana kwezinhloso zomqashwa nezomqashi.

Unayo imvume yokuchitha isikhathi sakho usebenzela umphakathi noma wenza umsebenzi wesihle (ongenankokhelo), noma uma umele ibhodi lemboni ezintweni ezizoba wusizo noma ezizozuzisa abakwa-Gold Fields, kodwa njalo qala ngokukhuluma nomuntu ofanele ukuze akweluleke ngalokhu uma ungaqinisekile. Ngabe isihlobo somsebenzi (indodana) sivumelekile ukuthi siqashwe ethimbeni elilodwa noma emnyangweni owenza umsebenzi ofanayo?



Ngaphandle uma izinqubomgomo ezikhona manje zikuvimbela lokhu, izihlobo zingasebenza endaweni eyodwa yokusebenzela. Kodwa-ke, akumele omunye abike komunye ngqo phakathi kwezihlobo futhi asikho isihlobo okumele sibe yingxenye yesinqumo sokuqasha noma ukuba yinduna yomuntu oyisihlobo sakhe futhi akumele kuthikameze imigomo noma imibandela yokuqasha, noma kuthonye ukupathwa kwesihlobo lesa. Umuntu kumele **aveze obala** ukuthi isihlobo sakhe singumsebenzi wenkampani noma womnyango.

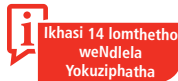

izipho, usizo, okokuzijabulisa, ezezivakashi noma umusa webhizinisini okungase kubeke (noma kubonakale sengathi kubeka) engcupheni umsebenzi wakho, ukungathathi uhlangothi kanye nokwethembeka kwakho wenzela ukuthi kuzuze abakwa-Gold Fields. Lokhu kusebenza nasemndenini wakho oseduze.

Ukukhokha ngemali engukheshi nakho akuvumelekile ngaphandle uma kuvunyiwe ngokulandela okuhlinzekelwa Yindlela Yokuziphatha.

Ungayemukela into eyigugu noma izinto zokukhangisa imikhiqizo zenani elincane (inani elincane ngesiFunda ngasinye lichaziwe emthethweni). **Kodwa khumbula ukuthi kumele usheshe ukudalule lokho okuwusizo, isipho noma umusa webhizinisi, ezezivakashi noma okokuzijabulisa okunikwa noma okwamukelwe nguwe noma okunikwe wena** – noma ngabe kuncane kangakanani, noma ngabe inani lakho lithini – kumuntu ofanele ngokuthi ukubhale phansi. Futhi bhala imininingwane yesipho, ezezivakashi kanye nokuzijabulisa ebhukwini lokubhalisa. Ilungu leSigungu esiphakeme seRijini noma ilungu leSigungu esiphakeme lakwa-Gold Field yilo eliphasisa liphinde ligcwalise ibhuku elibhalisa izipho, ezezivakashi nokuzijabulisa. Qinisekisa ukuthi akukho nqubo yamathenda eyenzekayo noma ngabe uyabandakanyeka kuyo noma cha.
